The applicant undertakes :

- a) To comply the particular provisions of the Council Regulation (EC) No 1255/1999 on the Common organisation of the market with milk and dairy products and the Commission Regulation (EC) No 1898/2005 laying down the detailed rules for implementing of the Council Regulation (EC) No 1255/1999 as regards measures for the disposal of cream, butter and concentrated butter on the Community market
- b) In case of success in tender to process or incorporate at least 5 tonnes of butter monthly, or 45 tonnes during the 12 months period or the equivalent corresponding to the quantities of the concentrated butter or cream, or intermediate products
- c) To keep records and supporting documents showing the quantities, composition and the suppliers of the fats used and the quantities, composition and butterfat content of the products obtained, and, except for establishments marketing final products at the retail stage, the date on which products leave the establishment and the names and addresses of their holders by references to delivery orders and invoices
- d) If he processes different products benefiting from aid or price reductions under different Community supported schemes :
 - to keep separately the records referred to in c)
 - to process those products successively
- e) In the case of the manufacture of milkfat intended for use within the manufacture of concentrated butter to keep accounts, showing the quantities of butter and their supplier, the quantities of milkfat obtained and the identification and the date of production and removal of each batch, identified to their manufacturing programme
- f) To submit the manufacturing programme to the APA
- g) To submit the data on his establishment in accordance with the templates in ANNEXES VIII – xii of the cR (EC) No 1898/2005
- h) Incorrect receipt of payment including rates and sanctions to return to Agricultural Paying Agency in accordance with the Act No 523/2004 of the Coll. of Actson the budgetary rules of the public administration as amended
- i) To Provide interoperation and enable to carry out controls and the on.spot-checks
